The meeting was called to order at 3:30 pm by Co-Chair Marshall.

Privilege of the Floor

No attendees requested privilege of the floor.

Approval of Minutes

Co-Chair Marshall asked if anyone had any questions or corrections for the April minutes. Motion was made by Supervisor Stressing to approve the April minutes, seconded by Supervisor Cowley. Motion carried.

Treasurer's Report

Mayor Palumbo then presented the bills totaling \$30,613.07. A motion to approve the bills as presented was made by Mayor Palumbo and seconded by Marty Aman. Motion carried.

Project and Grant Updates

Kevin Olvany provided updates on recent projects:

- Deuel Road Project Construction of six water quality basins and installation of hickenbottoms and tiles are underway to connect the flow between basins in order to help to dramatically reduce erosion and phosphorus loss from this field system. Additionally, the landowner has agreed to allow the lower 20 acres of the field to be converted from a row crop to a hay field is expected to significantly lower pollutant loading. The project received support from the Town of Canandaigua, the Town of Naples, and utilized the watershed excavator.
- Sucker Brook Submitting grant proposal to NYS DOS Inland Flooding and Local Waterfront Revitalization Program Implementation Project Program, NYS DOS Coastal Rehabilitation and

- Resiliency Projects Program, and NYS DEC Resiliency Watershed Grant Program for construction of Sucker Brook resiliency projects.
- Upcoming CFA Grants Will be applying for road bank stabilization and the possible acquisition of a property just south of the City intake pipe in the Town of Canandaigua.

9 E Project Funding / Friends of Canandaigua Lake

Kevin explained the 6 year funding strategy for the full implementation of the 9E plan to achieve a 25% reduction in phosphorus loads and provide greater flood resiliency. On the governmental side, we need to showcase \$35 million in federal, state and local in-kind/cash contributions towards the overall \$50 million goal. The private side goal is to fundraise \$15 million toward the \$50 million goal. The Watershed Council reviewed the types of projects that can be utilized to achieve the public funding goals and are encouraged to document the types of projects occurring in their municipality that helps to reach these goals.

Docks & Moorings

The last Docks and Moorings Committee meeting raised more questions that need to be addressed. Kevin will reach out to Ontario County Planning to see if they could assist for SEQR and technical reviews. The process needs another year to draft final changes and get public input.

Manager / Technician Report was reviewed with additional current projects.

A motion to adjourn was made by Supervisor Cowley, seconded by Supervisor Stressing. Motion carried.
